Pursuant to the Law of Georgia On Free Industrial Zones; The Decree of the Government of Georgia #131 dated June 3, 2008 on Approval of the Rules on Creation, Arrangement and Operation of Free Zone; The Decree of the Government of Georgia #109 dated March 10, 2015 on the creation of Hualing Kutaisi Free Industrial Zone and the Tax Code of Georgia:

- a) A legal entity incorporated in the Free Industrial Zone of Georgia is exempt from the Corporate Tax, Dividend Tax, Property Tax and the VAT, as defined by the applicable Georgian legislation,
- b) **A legal entity incorporated in the Free Industrial Zone of Georgia, complying with the applicable Georgian legislation and the relevant license issued by the Free Industrial Zone Administrator, conducts its business operations in the field of Financial Consulting and Services, including, but not limited to the cryptocurrency exchange, security token trading, ICO launch, e-wallet and remittance services to customers outside the Republic of Georgia and Non-Georgian citizens and residents;**
- c) The prohibited activities and operations on the territory of the Free Industrial Zone include: production, supply and storage of the weapons and/or ammunition; production, processing/recycling and Storage of the nuclear or other radioactive substances; production, processing/recycling and storage of narcotics and the psychotropic drugs; import, storage, processing and/or supply of tobacco and/or tobacco products.
